Whereas the Board of Directors of Metro Systems Corporation Public Company Limited ("the Company") convened Board of Directors Meeting No. 2/2024 on February 22, 2024 from 1.00 p.m. to 3.00 p.m. at the meeting room of building A floor 2 of Metro Systems Corporation Public Company Limited, where is located at No. 400, Chalermprakiat Rama IX Road, Nongbon, Prawet, Bangkok.

The Company would like to report the resolutions of Board of Directors Meeting as follows;

1. To acknowledge the report of the Company's operating results for the year ending December 31, 2023 and Annual Report for the year 2023.

Resolution

The meeting has an opinion to propose the Company's operating results for the year ending December 31, 2023 and Annual Report 2023 to the meeting of Annual General Meeting for acknowledgement.

2. Approved the Statement of Financial Position and Statement of Comprehensive Income for the fiscal period ending December 31, 2023.

Resolution

The meeting has an opinion to propose to the Annual General Meeting for approval of the Statement of Financial Position and Statement of Comprehensive Income for the fiscal period ending December 31, 2023 which were audited by the Company's auditors and consent from the Audit Committee and Board of Directors.

3. Approved the profit allocation and dividend payment for the year 2023.

Resolution

The meeting has an opinion to propose to the Annual General Meeting for the profit allocation and dividend payment according to the 2023 operation results at the rate of THB 0.50 per share, amounting to THB 180,000,000 to the Company's shareholders on the date of April 24, 2024.

However, the right to receive the dividend is pending to shareholders approval at Annual General Meeting.

4. Approved the election of directors in place of those retiring by rotation.

Resolution

The meeting acknowledged that (1) Mr. Sunpitt Sethpornpong (2) Mr. Narong Charuvajana (3) Dr. Virach Aphimeteetamrong will retire by rotation at the 2024 Annual General Meeting. However, the Board of Directors propose to elect these directors at the Annual General Meeting as the directors of the Company for another term according to the opinion of the Nominating and Remuneration Sub-Committee.

Nevertheless, the those three retiring directors have completely qualification of the directors in accordance with the Articles of Association, the Public Limited Companies Act, the Securities and Exchange Act and Company's rules including to completed the consideration from

Nominating and remuneration Sub-Committee to ensure that these retiring directors are being a director who brings knowledge, experience and expertise to give suggestions that are useful in the business of the Company. For Dr. Virach Aphimeteetamrong, he has taken a position of independent director for a period of 29 years. If he is elected to this position for another term, the total duration will be counted to 32 years. Therefore, the Board of Director has considered that this proposed person in the position of independent director could advise independently and has qualified completely as the definition of the independent director in accordance to the definition of the independent directors and the rule of The Securities and Exchange Commission and The Stock Exchange of Thailand.

Therefore, the shareholder has the right to propose nominees to be considered for the election as director at the Annual General Meeting No.29/2024 which the submitting period was from September 4, 2023 to November 30, 2023. After the period ended, there was no nominee to be proposed as director into the agenda.

5. Approved the remuneration of Directors for the year 2024.

Resolution

The meeting has an opinion to propose to the Annual General Meeting for specifying the remuneration of the Board of Directors, the Audit Committee, the Executive Committee and the other committees for the year 2024 which was examined by the Nominating and Remuneration Sub-Committee as follows;

License No.10985 of Deloitte Touche Tohmatsu Jaiyos Audit Company Limited as auditors of the Company for the fiscal year 2024 and to fix the auditor's remuneration for the annual financial statement of the Company in the amount of THB 1,460,000 and the financial statement for three quarters in the amount of THB 1,440,000. Therefore, the total amount of the auditor's remuneration for the year 2024 is THB 2,900,000.
